

COVID-19 ASSUMPTION OF RISK, WAIVER, AND RELEASE

Please read carefully before signing.

I, the undersigned, have requested that General Computer Services II, Inc. trading as the Rockville Duplicate Bridge Club, ("RDBC") provide me with access to and/or use of its facilities and amenities located. In consideration for my access to the property, now or in the future, I knowingly and voluntarily covenant and agree as follows:

COVID-19 Assumption of Risk and Certain Acknowledgments

The World Health Organization declared the novel coronavirus, COVID-19, a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. RDBC cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while being present in the premises. Therefore, if you choose to attend and play bridge at RDBC, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

I agree that I am personally responsible for my safety and actions while on the premises of RDBC. I agree to comply with all policies and rules of RDBC, including all guidelines, signage and instructions. I understand that contracting COVID-19 could result in serious medical symptoms requiring medical treatment in a hospital or could possibly lead to death. I further understand that no actions by RDBC will guarantee that I will not contract COVID-19. On behalf of myself and my heirs, successors, and assigns, by accessing and using the property, I knowingly and freely assume all risks, both known and unknown, related to COVID-19, including all illnesses, injuries, damages or death arising therefrom.

I have read and understood the above warning concerning COVID-19. I hereby voluntarily choose to accept all foregoing risks of contracting COVID-19 for myself in order to attend and play bridge at RDBC. These services are of such value to me that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend rather than arranging for an alternative method of enjoying the same services virtually. I accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in RDBC events.

My Commitments

Please acknowledge and indicate your commitment to and agreement with the following with your initials below:

I have not experienced any cold or flu-like symptoms (fever, cough, shortness of breath, etc.) or tested positive for COVID-19 in the last 14 days.

I have not had close contact with or cared for someone diagnosed with COVID-19 within the last 14 days.

I will frequently wash my hands or use hand sanitizer during the event at the Property.

I understand that masks are now optional and not mandatory at the Property and I will use my own judgment whether to wear a mask.

I understand that I will be denied entry to the Property if I demonstrate symptoms of COVID-19 or if entry to the Property presents an unreasonable health hazard to other visitors, the public, or as determined by RDBC in its sole discretion.

Waiver, Release, and Indemnification

I, on behalf of myself and my heirs, successors and assigns, voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify RDBC, directors, officers, insurers, successors, and assigns (collectively, the "Indemnified") from any and all claims, demands, torts, contracts, obligations, suits, actions, causes of action, or damages ("Losses") arising from or related to COVID-19 connected in any way with my access or use of the Property, including, but not limited to, claims based on the alleged negligence of any Indemnified or any other person. [I further promise not to sue RDBC or any Indemnified for any illness, injury, death, or other Losses arising out of or related to COVID-19 and agree to indemnify and hold them harmless from any and all Losses resulting therefrom. I have read this *COVID-19 Assumption of Risk, Waiver, and Release* carefully. I fully understand its terms. I executed this Agreement knowingly, freely, and voluntarily without any inducement, duress or coercion, intending to be legally bound.
